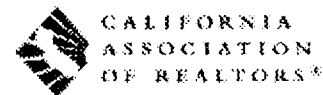

**SUGGESTED GUIDELINES & PROCEDURES**

- 1  The following must accompany the application: \_\_\_ official transcript from all colleges/universities attended, \_\_\_ verification of current enrollment, \_\_\_ two letters of recommendation, \_\_\_ a typed, 300 word essay explaining your career objectives in the real estate industry.
- 2  Student must plan on entering the field of real estate upon graduation.
- 3  Student must be an undergraduate, matriculating from a 2 or 4 year California college/university.
- 4  Student must be at least a sophomore (completed 30 units)
- 5  Student must attend full-time (minimum of 12 units), and at least one of the courses must be a 3 unit real estate course. Student must successfully complete the real estate course within on year of scholarship funding.
- 6  Student must have successfully completed two real estate courses or have a California real estate license.
- 7  Student must have maintained a cumulative grade point average of 2.6 (from all colleges attended).
- 8  Student must be a legal resident of California for at least one year and have a valid California Driver's License or California State Identification.
