



The REALTOR® of the Year Committee is accepting nominations for the 2014 REALTOR® of the Year Award. The purpose of this prestigious award is to recognize a member of our Association who has provided outstanding service to the real estate profession and to the community through their membership in the Citrus Valley Association of REALTORS®.

The Committee is requesting each member submit the name of a member they feel deserves this recognition including a brief outline giving reasons why the Committee should select the candidate.

The Committee has established the following eligibility requirements and standards expected of the individuals being considered for this Award.

1. Nominee must be a member in good standing of the Association, paying dues as a REALTOR® member.
2. Any member may nominate one or more candidates as REALTOR® of the Year; however, the final decision will be at the discretion of the Committee.
3. The Committee shall be comprised of seven REALTOR® members appointed by the President. Three members will be past recipients of the Award, two members from the Board of Directors, and two members from the membership-at-large. At least five of the seven Committee members must be present at the selection meeting.
4. The current President and past recipients are not eligible to receive the Award.
5. In the opinion of the Committee, if there is no one deserving of the Award, no Award will be given.
6. The Committee has suggested five areas to determine the recipient of the high honor.
  - a. REALTOR® Spirit: High principles, faithfulness to laws and regulations of the Code of Ethics and local Association, furtherance of principles of good real estate practice among other brokers and general public.
  - b. Local Association Activity: Association offices held and committee work; special assignments; seminar and education work; membership and offices in local chapters of Institutes, Societies, etc.
  - c. State and National Association Activity: Participation at the State and National Association levels.
  - d. Community Involvement/Civic Activity: Local, state and national level participation in civic and services clubs, charitable activities, political action, fraternal or religious groups, etc.
  - e. Business Accomplishments: Recognized good business conduct; service to clients; imaginative and creative advertising programs; rehabilitation work; land utilization, etc.
